Here are 10 things to do—quickly:

1. Call Mike Ross (231-651-0604) or John Chahbazi (810-487-0393) now and volunteer to either canvass or drive canvassers. This is crucial!
2. Reserve Nov. 3 & 4 to help our huge “knock and drop” home delivery project.
3. Take Nov. 6 off to poll-watch, phone-bank, or host our Headquarters Victory Party.
4. Visit BenzieDemocrats.com, find your county commission candidate, email their photo/bio to five neighbors in your district, and urge them to vote for them.
5. Check out our other commission candidates and email their stuff to friends in those districts.
6. Write a letter now to the *Benzie County Record Patriot* for your county commissioner, House candidate Kathy Wiejaczka, state Senate candidate Mike Taillard, or Congressional candidate Matt Morgan (running against Jack Bergman.) Under 300 words, please, with name and phone number.
7. Urge friends to vote the entire Democratic ticket. (Many top Republicans agree, to force their Party to sober up.)
8. Yard signs! If your road's slow, find a friend on a busier one. Offer to pick up signs at HQ, put 'em up, and take 'em down. They're going fast! Headquarters is open M-Th 10 to 7, 'til 4 on Fridays, and Saturdays 9 to noon.
9. Donate to Kathy, Mike, and/or Matt. They need every dime!
10. Ask a young person you know to promise to vote Nov. 6.

Vote absentee: request your ballot now

Absentee ballots are a convenient, increasingly popular way to vote. The process requires a few steps before election day, but it's a good way to avoid long lines or mobility problems at the poll.

First, you must apply for an absentee ballot. Call your township or city clerk and ask for a ballot application, which they can mail to you—or stop by and pick one up and either take it home or fill it out on the spot. Either way, your completed application must be back to the clerk's office no later than 2 p.m. the Saturday before the election. It's best to submit it right away. There is also a link on our website to download the application form.

The clerk processes your application immediately, checking paperwork and registration, and mails your official paper ballot to any address you choose.

Then, you must either mail or hand-deliver your filled-out ballot to your clerk so that it arrives no later than 8 p.m. election day. You must **sign your return envelope**, and it must match the signature the office has.

So all that's required is some planning ahead.

Who can vote absentee? Any registered voter who's 60 or older, or is unable to vote without assistance at the polls, expects to be out of town on election day (long work commutes included), is in jail awaiting arraignment or trial, or can't attend the polls for religious reasons.

To get this going, visit BenzieDemocrats.com, click on "About Benzie," find your township or city's information, and request the ballot application.

One important exception: If this is your first time voting, you must vote in person, unless you are disabled or 60 years old or older.

Support our County Commission candidates!

For the first time in years, lots of Democrats are running for Benzie County Commission seats—five of the seven seats, in fact, so we now have a shot at winning a board majority. These are races where a little extra time, effort, and money from us can make a big difference. If you live in one of these districts, do contact your good neighbor who's running and ask how you can help *now*. A terrific first step is to have a house party, invite a few people, help make some introductions, and maybe raise a few bucks for your most local candidate. Here's our fine lineup:

GOP war on voters continues

A 2016 law passed by the Republican-controlled Legislature banned straight-ticket voting in Michigan, and a recent court ruling means that straight-ticket voting won't be available as an option in the Nov. 6 general election. That means that instead of making one mark to vote for all Democrats, we will have to make individual marks for each one.

A ruling by a federal judge in Detroit would have struck down the ban, but in early September the U.S. 6th Circuit Court of Appeals, in a 2-1 decision marked by a sharply worded dissent, blocked that ruling.

The *Detroit Free Press* reports that many local clerks have said that the ban could result in lengthy delays to vote in cities such as Detroit and Flint. That's exactly what Republicans are hoping for, since big cities are Democratic strongholds.

This situation is addressed by ballot Proposal 3, so remember to vote for it and the other two proposals offered on Nov. 6. See page 3.

Coury Carland is a Frankfort High School grad, was a candidate for sheriff in 2012, and won a commissioner seat in 2014. Our lone Dem commissioner richly deserves some like-minded board colleagues. Coury represents Benzonia Township—County District 4. Reach Coury at carland82@gmail.com.

BALLOT INITIATIVES

The Benzie County Democratic Party endorses the following three proposals appearing on the 2018 ballot.

Proposal 1, Marijuana Legalization Initiative.

A “yes” vote supports legalizing the recreational use and possession of marijuana for persons 21 years of age or older and enacting a tax on marijuana sales. The law would authorize and legalize possession, use, and cultivation of marijuana products by individuals who are at least 21 years old, and the commercial sales of marijuana through state-licensed retailers. Proposal 2, The Michigan Independent Redistricting Commission Initiative

(Michigan Constitutional Amendment). A “yes” vote supports transferring the power to draw the state’s congressional and legislative districts from the Michigan Legislature to an independent redistricting commission.

Redistricting is the process used to create voting districts from which we elect our U.S. representative and our state legislators. When that process is manipulated to benefit one party it is called gerrymandering. After the last census, and according to law, the districts were drawn by the state Legislature, which Republicans controlled, and boy were they gerrymandered!

Michigan voters are about half Democrats and half Republicans, but due to gerrymandering, Republicans took 64 percent of the seats in the Michigan Legislature. The only way for state government to truly represent Michigan citizenry is to end the manipulation of voting districts. It is so important to pass Proposal 2! Questions? Visit votersnotpoliticians.com, the nonpartisan group that led the stop gerrymandering effort.

Proposal 3, Promote the Vote

(Michigan voter regulations; Michigan Constitutional Amendment). A “yes” vote will improve voter access for all **U.S. citizens eligible to vote in Michigan**. Unless the voter declines, she will automatically become registered to vote when applying for, updating, or renewing a driver’s license or state-issued personal identification card. With proof of residency, a voter can simultaneously register to vote and obtain a ballot during the two-week period prior to an election, up to and including Election Day. A voter can obtain an absent voter ballot without providing a reason, and voters would be allowed to cast a straight-ticket vote for all candidates of a particular political party when voting in a partisan general election.

- Allow individuals 21 and older to purchase, possess and use marijuana and marijuana-infused edibles, and grow up to 12 marijuana plants for personal consumption.
- Impose a 10-ounce limit for marijuana kept at residences and require amounts over 2.5 ounces be secured in locked containers.
- Create a state licensing system for marijuana businesses and allow municipalities to ban or restrict them.
- Permit retail sales of marijuana and edibles subject to a 10 percent tax, dedicated to implementation costs, clinical trials, schools, roads, and municipalities where marijuana businesses are located.
- Change several current violations from crimes to civil infractions.
